* The introduction part of the paper is well-written. However, I recommend citing a few research articles from the year 2022/2023. Here are some research articles from the cognate discipline that will help further strengthen the arguments:

- * The authors need to further strengthen the literature review section. Though, the author did provide many significant studies, which are also appropriate. However, the author must mention more recent research studies in the relevant field of carbon emission and natural resources. Please include the following papers in your literature review since they are relevant to this research study and add to the body of knowledge.
- * In the discussion part, the study has discussed all of the major findings, however, it did not compare them adequately with the prior published work. The author explained their findings thoroughly. However, the authors need to



explain how these results are similar or different from previous studies.

* In the methodology part, the study has discussed all of the major techniques, however, the author has not mentioned or cite those previous studies that followed/used those techniques. For example unit root testing is not checked.

Therefore, I recommend citing few articles that must be cited in the revised draft. Similarly variance inflation factor (VIF) test explanations can be seen in the last three articles and can be added to his study.
