The values that are emphasized in local cultures, such as politeness, respect for parents and figures of authority, solidarity within communities, and reverence for traditions and cultural heritage, lay the groundwork for children to comprehend and internalize ethical behavior.

Secondly, children learn about ethical values through regular participation in rituals, celebrations, and cultural practices within their daily lives. By engaging in traditional ceremonies, cultural festivals, or religious rituals, children become familiar with important moral and spiritual concepts within their own culture.

Furthermore, culture and tradition also play a role in determining the social norms that are upheld in society. Through observing social traditions, community norms, and cultural conventions established by their ancestors, children become acquainted with accepted and valued behaviors within their communities.

In this context, it is crucial for educators and communities to understand and appreciate the role of culture and tradition in the formation of ethical values and norms in children. Efforts to preserve and reinforce positive cultural values can assist children in understanding their own identities and developing responsible attitudes towards their culture. Additionally, multicultural education and the appreciation of cultural diversity can provide children with a broader understanding of ethical values within complex global contexts. Thus, culture and tradition play a vital role in shaping the character and morality of children, helping them develop inclusive and tolerant attitudes within an increasingly global society.

### *Cross-cultural interaction*

Cross-cultural interaction plays a significant role in shaping the ethical values and norms of children, particularly in the context of globalization. Research suggests that multicultural education promotes tolerance and acceptance of diverse moral ideals (Babu 2023). Intercultural education aims to foster openness, tolerance, and acceptance of others, thereby enhancing positive intercultural relations (Suradi, Nilawati, and Gustari 2022). Moreover, studies have shown that cultural differences influence the development of moral reasoning in children. For example, parents in the United States and Japan have different approaches when discussing moral actions with their children (Torkos and Egerau 2022).

Additionally, online cross-cultural projects have been found to effectively cultivate global awareness in high school students, highlighting the importance of collaborative experiences and teacher involvement in shaping children's perspectives on global issues (Senzaki et al. 2022). Overall, these findings underscore the importance of cross-cultural interaction in enriching children's ethical values and broadening their worldview.

The impact of cross-cultural interaction on the formation of ethical values and norms in children can be summarized as follows: Firstly, cross-cultural interaction provides children with firsthand exposure to cultural diversity. By interacting with individuals from diverse cultural backgrounds, children come to understand that ethical values are not universal but rather contingent upon cultural context. This fosters attitudes of openness, tolerance, and appreciation for diversity within society.

Secondly, cross-cultural interaction expands children's understanding of social realities and living conditions in different parts of the world. Children gain insight into the differences in moral values, social norms, and challenges faced by communities globally. This, in turn, facilitates the development of empathy and a deeper appreciation for the experiences of others.

Furthermore, cross-cultural interactions offer opportunities for children to develop essential cross-cultural communication skills in an increasingly interconnected world. Through cultural exchange, collaboration, and cooperation with individuals from diverse cultural backgrounds, children learn to build mutually beneficial relationships and navigate the complexities of cross-cultural interactions.

Given these benefits, it is crucial for educators and parents to actively support and facilitate cross-cultural interaction for children. Educational programs that incorporate cross-cultural elements, student exchanges, and intercultural collaborative activities can serve as effective means of expanding children's understanding of ethical values and norms within our complex global landscape. In essence, cross-cultural interactions play a pivotal role in shaping children's character and morality, enabling them to become ethical global citizens in our increasingly interconnected society.

## Conclusion

In conclusion, this scientific article examines the formation of ethical values and norms in children within the context of globalization. Based on the conducted discussions, it is evident that several complex factors influence the development of these values and norms. These factors include the impact of mass media and technology, the role of education and the school environment, family influences, cultural traditions, and cross-cultural interactions.

Firstly, the influence of mass media and technology can significantly shape children's perceptions and values, thereby affecting their moral development. Secondly, education and the school environment play a crucial role in establishing the groundwork for learning moral values and character, while families provide models and moral norms that children apply in their everyday lives. Thirdly, local cultures and traditions serve as moral frameworks for children, and cross-cultural interactions broaden their perspective on diverse ethical values.

Based on these findings, several suggestions can be made for further research and practice. Firstly, it is essential to adopt a holistic and multidisciplinary approach to understand and discuss the formation of ethical values and norms in children. This approach will provide a more comprehensive understanding of the various factors involved in this process. Secondly, educators, parents, and communities need to strengthen their roles in shaping children's ethical values and norms. This can be achieved through structured character education programs, promoting open communication and empathy within families, and efforts to uphold and reinforce positive cultural values.

Lastly, additional research is required to explore the influence of the factors identified in this article and develop effective strategies to help children develop responsible and ethical attitudes in our increasingly complex and interconnected global society.

By taking these steps, it is hoped that we can better understand and support the formation of positive ethical values and norms in children. Ultimately, this will help them become ethical global citizens in the era of globalization.

## Contribution

These conclusions have the potential to make significant contributions to a wide range of stakeholders, including churches, particularly in the context of Sunday schools, practitioners, researchers, and policymakers. For churches, especially in Sunday school management, these findings can serve as a foundation for enhancing a comprehensive approach to religious education. This approach transcends mere instruction on religious doctrine and incorporates the integration of ethical and moral values into children's learning. This presents an opportunity for the church to become a more influential agent in shaping children's character in alignment with their religious teachings.

Practitioners in the field of child education can utilize these findings to develop more targeted teaching strategies. These strategies can assist children in comprehending and internalizing moral values in their daily lives. Additionally, researchers can expand on this study by further examining the interactions among factors that influence the development of ethical values and norms in children. This deeper understanding can yield valuable insights for practitioners and policymakers. Similarly, policymakers can employ these findings as a basis for designing more inclusive educational and social policies. These policies should consider the significance of nurturing children's character and morality within society.

By integrating the findings from this research into practice and policy, churches, practitioners, researchers, and policymakers can effectively promote the cultivation of positive ethical values and norms in children. This will aid children in becoming more responsible and ethical individuals in an ever more intricate society.
