The introduction of the article was developed without the proper theoretical foundation to support the mentioned information. It is recommended to include citations to consolidate the presented data.

Improvements can be made to enrich the text, such as incorporating measurable data and avoiding generalizations. For example, when mentioning the diversity of traditional systems, it would be advantageous to provide a more precise description of this diversity by mentioning specific numbers or examples.



Similarly, when mentioning tribes in Indonesia, it is important to provide more detailed information, such as the number of existing tribes and citing some of them as examples.

The work lacks numerical and statistical data to support the presented information. An evidence-based approach, using measurable data, would add value and reliability to the conveyed message.

Furthermore, it would be beneficial to structure the work in a more organized manner, presenting graphs, figures, and flowcharts that make the information clearer and visually understandable for the reader.

The reference list presented at the end of the paper is not cited throughout the text. Additionally, over 50% of the references have publication dates of more than 5 years, and almost 45% have publication dates of more than 10 years. Considering that the topic being discussed is current, there are many more recent works on this subject that could be cited to enhance and keep the topic up to date.
