# Weakness of the Research Paper:

# 2. Absence of Considering Social Stigma:

While the study explores gender differences in preferences, it could have considered the underlying societal factors influencing these preferences and the evolving gender roles within the context of arranged marriages. In the Indian context, girls finding a match through an online route has a social stigma associated with it.

## 3. Avoided Few Demographic Factors:

The study's findings might be somewhat relevant to individuals using matrimonial sites in urban areas. However, it doesn't adequately capture the preferences of the rural population in India.

#### 4. Not Much About Limitations:

It's interesting that the authors don't really talk about the weaknesses of their study. They also seem to accept what participants said without much critical thinking.

### **Scope of Improvement:**

- 1. The methods of data collection, such as online surveys, focused groups, and collection of data from matrimonial sites, can add on to access a wider sample size.
- 2. Authors need to mention the limitations of the selected samples on generalizing the findings.
- 3. Explore how societal pressures and expectations around gender roles affect what both men and women want and go through when using matrimonial sites.

This study provides valuable insights into the social and demographic profiles, partner preferences of individuals, and multifocal experiences of individuals using matrimonial sites in India.

However, addressing the loopholes and incorporating the suggestions for improvement may further strengthen this research and enhance its contribution to the understanding of this topic.
