This addition would serve to elucidate the specific research design, data sources, data collection methods, and analytical techniques utilized in the study. A clear exposition of the methodology not only enhances the transparency and reproducibility of the research but also strengthens the overall validity and credibility of the findings.

Integration of Empirical Data Analysis:

The introduction of empirical data analysis would substantially enrich the paper's depth and empirical rigor. Utilizing quantitative data from reputable sources and applying statistical methods to examine the relationship between poverty and crime would offer a more grounded and quantifiable perspective. Techniques such as regression analysis or correlation studies could provide a robust statistical foundation to support the study's assertions and conclusions.

Incorporation of Comparative Analysis:
