effectiveness of the IWSM approach over time. Including metrics for success, periodic assessments, and adaptive management strategies would contribute to continuous improvement and learning.

Recognizing the diversity of semi-arid regions and tailoring the approach to different contexts would enhance its scalability and effectiveness.
- -The paper could benefit from a more explicit roadmap or structure at the beginning to guide the reader through the content.
- -The abstract is concise, but it could be more explicit about the specific findings or contributions of the paper.

- -In Subsection 3.1: Assuring institutional, legal, and policy support: Consider providing specific examples or case studies where institutional support has made a difference.
- -Subsection 3.2: Assuring proper soil and water resource management in a watershed: The discussion is thorough. However, it might be beneficial to include some real-world examples or case studies to illustrate successful implementation.
- -Subsection 3.3: Assuring proper integration of agricultural inputs: Provide examples of successful integration of agricultural inputs in semi-arid regions.
- -Subsection 3.4: Establishment of a watershed-based scientific and technology platform: Expand on the challenges and opportunities in implementing such a platform.
- -Consider adding figures, tables, or graphs to illustrate key points and data, enhancing the visual appeal of the paper.
- -Emphasize the global relevance of the findings and recommendations. How can these insights be applied across different regions?
- -The manuscript could be substantially improved by relying and citing more on recent literature in the field sustainability and IWSM.
