From this point of view, the author studies the influence of parents' social and economic conditions on the personality of Christian teachers is a meaningful topic, but there are still some shortcomings in each part, which need to be further modified and improved.

Abstract

This part needs to be overhauled. In this sense, it should include a brief introduction to the background and purpose of the research, methods (data sources, data survey time, survey methods, etc.), empirical research results (parents' socio-economic conditions, teachers' parents' background, and the impact of the two on teachers' personality, it is necessary to explain the degree of influence and the direction of influence). Finally, the research conclusion, to clarify the significance and suggestions of the research results on the personality development of Christian teachers in Tambaksari District, Surabaya.

Introduction

1.The introduction is a very intensive part. At present, this part of the paper is written vaguely, and it is not clear to find out the necessity and novelty of the author to carry out this study, and what contribution this study has made is not known. especially, there are many studies on the influence of parents' socio-economic status on their children, we should highlight the influence of the social and cultural background of this study. In this sense, the current introduction does not deeply understand the author's original culture, but I know that there are cultural differences between the East and the West. The influence of family socio-economic conditions should be different, and the size and degree of influence should be different.

2.The author needs to provide readers with an in-depth literature review. However, it is difficult for me to understand and follow the introduction part of the thesis. Many problems may be due to the lack of high quality of the language of the thesis. In fact, this affects readers to understand the problems of this study.

3.The literature review section seems to have some irrelevant or off-topic information, without a good integration of relevant theories or existing research results, the author needs to add some literature and delete some research literature unrelated to the topic. My personal suggestion is to add a chapter ' Literature Review ' after the ' Introduction ' section.

Methodology

- 1.Due to the small sample size of this study, it is necessary to quote the authoritative literature used in small sample research to demonstrate the reliability and scientificity of this study, and integrate the ' B.Data collection technique ' and ' D. Data Analysis Techniques ' into the ' Methodology ' part.
- 2.The PLS-SEM and MTMM methods used in this study need to be introduced and explained in detail how they are used in this study.
- 3.Authors need to delete the ' 2.Literature Review ' and ' C. Research Instruments ' sections.

Result and Discussion

- 1.' A. Research variable ' this part needs to use a paragraph to explain the first-level indicators and second-level indicators, and needs to increase the reliability and validity test of the second-level indicators of X1, X2, and Y (report the coefficients of CFA and EFA tests).
- 2.' 2.Test the model or inner model ' this part, according to the PLS-SEM method mentioned above, it is necessary to present the empirical results in tables, and then report the impact effects, statistical significance, and R-Square estimates of the three research paths concerned in this study.
- 3.According to the obtained research relationship, that is, the structural equation model path map, it is very important to draw a visual path map, which clearly presents the relationship between latent variables and explicit variables to readers. And based on the above research results, it is explained whether the three hypotheses proposed in this study are verified or falsified.
- 4.I suggest that it is necessary to delete the title of ' Discussion ' in the title ' Result and Discussion ' part, and the title of this part is changed to ' Result '.

Discussion

- 1.Based on the results of empirical research, according to relevant literature and theories, find a reasonable explanation mechanism, compare the differences with previous studies on the influence of parents ' socioeconomic status on their children 's professional ability, teaching ability, personal ability and social ability, and explain the essential reasons behind the similarities and differences.
- 2.This section should incorporate my comments from the ' Introduction '. Furthermore, this section should be constructed from a unitary point of view, explaining in detail the results achieved, comparing it with previous studies and above all with a theoretical framework.
- 3.The ' Contribution ' part is integrated into the ' Discussion ' part, and the ' Contribution ' is no longer written separately.

Conclusion

This part needs to be further modified to add whether the research hypothesis is verified.

In summary, I strongly suggest that the author needs to make major changes to this research paper, and look forward to

seeing a high-quality manuscript after the modification. Wish you all the best !
