This could include discussing potential obstacles and how to overcome them.

Integration of Technology: In today's digital age, it would be valuable to discuss how technology can be integrated into public speaking training. Online tools, virtual platforms, and video presentations are becoming increasingly important, especially in light of remote learning environments.

Measuring Training Effectiveness: The paper mentions evaluation and feedback mechanisms but does not provide details on how to measure the effectiveness of the training plan. Including specific assessment methods and criteria would be beneficial.

Real-Life Application: While the training plan covers various aspects of public speaking, it could be enhanced by providing real-life examples or case studies demonstrating how these skills are applied in professional or academic settings.

Ethical Considerations: Public speaking often involves addressing sensitive topics or diverse audiences. The paper could discuss ethical considerations in public speaking, such as avoiding offensive language or ensuring inclusivity in speech content.
