You can start by talking about the definition of the topic, add information regarding components, and how those components have evolved over time. Finish by indicating the novelty or

research gap. In this sense, you can join this section with Related Works, which requires an introductory statement to preface the synthesis of selected studies. Moreover, there needs to be a clear articulation of how these studies correlate with the article's objectives.

### **Methodology and Results:**

In the methodology section, please add information on database sources and the queries explicitly. Noting the components of the query will be an extra step; also, try to use as many synonyms and equivalences as possible and applicable. The absence of a distinct "Results" section leaves a gap that precludes a seamless transition into the discussion. I suggest delineating the practical and theoretical implications to align with the literature review.

Finally, keep working on your paper; I hope to see the next version.
