The manuscript entitled "Supplementation with Vitamin D, Zinc, and Quercetin to Treat COVID-19: A Case Report" by Brett Martin, in this case report, COVID symptoms may have improved as a result of the supplements' capacity to promote immune function while reducing inflammation and oxidative stress. The activity of NF-B, IL-1, IL-6, IL-8, TNF-, MCP-1, and CRP is increased when a coronavirus is present. Quercetin, zinc, and vitamin D can suppress NF-B activation and stop the release of IL-1, IL-6, IL-8, TNF-, MCP-1, and CRP. Her symptoms were managed by taking 1,000 milligrammes of quercetin, 100 mg of zinc, and 5,000 IU of vitamin D three times a day with meals. Her nasal congestion and exhaustion started to improve after just one day of dosage. Her cough subsided after three days of dosage, and her weariness, nasal congestion, ageusia, and anosmia all significantly improved. After six days of therapy, all symptoms completely disappeared.
