The paper lacks a discussion on the external validity of the study, limiting the generalizability of the findings to other contexts or populations. Including considerations about the study's external validity would provide readers with insights into the broader applicability of the research.

While the paper discusses effect sizes, the interpretation could be more detailed, offering insights into the practical significance of the observed effects on customer trust. Providing context for the effect sizes would enhance the reader's understanding of the study's impact.

While the predictive relevance is mentioned, the paper could benefit from a discussion on the practical implications of the predictive model. Addressing the practical significance of the predictive model's findings would contribute to the study's overall relevance.
