  lack of access to finance. Many small businesses struggle to secure loans from financial institutions due to limited
  collateral or a lack of business history. This restricts their ability to expand operations or invest in new technologies.
  Additionally, high interest rates and stringent loan requirements further exacerbate the financial constraints faced by
  these enterprises (Anne, 2014)." This expression was needed in the result part, not in the introduction part.
