With regard to SVB and CBDCs, I think the most effective way through which CBDCs could prevent a SVB-style collapse in the future would be the quick transfer to large sums of money to SVB from the Federal Reserve using CBDC such that, as depositors withdraw their money from the bank, the FED can respond by pumping in more money to the bank to digitally offset the run on bank deposits.
