- 2. **Potential Bias in Narrative**: While the article aims to provide a balanced view, there are sections where the narrative could be perceived as slightly biased towards highlighting the criminal aspects of TLE. A more balanced discussion of the non-criminal implications could provide a fuller picture of the condition's impact on individuals.
- 3. Lack of Discussion on Methodological Limitations: The review discusses various studies and findings without substantial critique of their methodologies. Including a discussion on the limitations of existing studies could enhance



the credibility of the review and provide a clearer picture of where further research is needed.

4. Accessibility for Broader Audiences: The article is dense with technical jargon and detailed medical and legal discussions, which might make it less accessible to readers who are not specialists in these fields. Simplifying the language or providing summaries for complex sections could make the content more accessible to non-specialists.
