- The references section should be consistent in formatting, and the inclusion of publication dates for the sources would further strengthen the scholarly foundation of the article.

3. Depth in Certain Sections:

- While the article provides a good overview, some sections could benefit from a deeper analysis. For instance, the discussion on the smart lockdown policy in Pakistan could be more detailed, including the outcomes and challenges faced during its implementation.
- Psychological Effects of COVID-19 : this section is missing many information about depression anxious disorder and quality of life, this article deals only with quarantine and doesn't explain psychological effect of other facets of

4. **Update of Information:**

- The article references events and data from earlier in the pandemic (e.g., in 2020). To maintain relevance, it would be beneficial to include more recent information, especially as the understanding of COVID-19 evolves, and new data becomes available.

5. **Engagement with Counterarguments:**

- The article primarily presents information from one perspective. Including counterarguments or acknowledging different viewpoints on certain topics, such as the effectiveness of lockdowns, could strengthen the overall argument and demonstrate a more nuanced understanding of the subject.

6. **Language and Style:**

- The language, while generally clear, could benefit from more concise expression in some places. Avoiding redundancy and tightening the prose would enhance the article's impact.
- The abstract is informative but could be more succinct while still capturing the essence of the research.

7. **Visual Aids:**

- Although the article mentions figures, it lacks actual visual aids like graphs or charts. Incorporating visuals could help convey complex information more effectively, especially in sections discussing transmission modes.

8. **Global Perspective:**

- The article tends to focus more on Pakistan's experience. While this is valuable, providing a broader global context or comparing the situation in Pakistan with other countries could enrich the analysis.

Addressing these weaknesses could further elevate the quality and impact of the article.
