Furthermore, details regarding the location of this city and the significance of analyzing women-owned small and medium-sized enterprises in that area must be provided.

The authors should provide information for the inclusion of the following four factors in the research objectives: technological, individual, legal administrative, and economical. If the hypothesis has been explained in section 2, there is no need to write it in the introduction section. However, it would be better if Figure 1 displayed the hypothesis number. Following the research objectives, the author should describe how the article is organized.

Kindly fix the spacing in section two. Factors in part 2 (for example, economic factors) need to be written with subheadings and briefly discussed before moving on to the elements. The authors can write more neatly by aligning left and right throughout the article.

It is written 'According to the Micro and Small Scale 2019 annual report, there are 531,732,185,421, and 114 women micro and small-scale enterprises in manufacturing, service, trade, construction, and urban agriculture, respectively,' please write again in a clear, well-organized manner. Please explain the purpose and owner of an annual report. Although the sample size calculation for each sector has been given by the authors, it is still required to provide information on how to select a sample that corresponds with the sample size in each sector, as well as how the survey was conducted.

Pearson correlation matrix, regression, and ANOVA were performed by the authors. It is essential to clarify the objectives of these analyses. Then, the analyses' findings confirm which hypothesis. Confirmation of the hypotheses should be supported by justification from earlier studies. As a result, it is clear to determine whether the study's findings and those of



previous research are comparable or different.

The author should discuss the general research findings in the conclusion rather than focusing on each hypothesis. The contribution of the research should be stated, either in the introduction or after the conclusion.

Please proofread the entire article, making sure that all paragraphs, subheadings, references, and spacing are all in order. Kindly place the explanations for the figures and tables before they are displayed, not later. It's uncommon to write a bibliography in bullets; please fix it.
