Suggestions for Improvement:

Conciseness in Results and Discussion: To address the issue of excessive detail, the authors should revise the results and discussion sections, focusing on the most significant findings and their implications. This will enhance the readability and impact of the article.

Reviewer Comment Clarity: When providing feedback to the authors, it is essential to ensure that comments are clear, specific, and actionable. This will assist the authors in making the necessary improvements to their article.

In conclusion, the article tackles an important topic, and its objectives are well-defined. However, addressing the weaknesses, such as updating references and streamlining the results and discussion sections, will strengthen the overall quality of the manuscript. I recommend that the authors carefully consider these suggestions as they prepare their revised manuscript for resubmission.
