- 1. The title and abstract appears to cover all the information about the *P. marsupium Roxb* all over the world. However, the introduction is quite region-specific and majorly explains its significance in India only. Clear this confusion in your manuscript. Does it not have importance in other regions of the world?
- 2. In 'botanical description', it would be better if you include the seasonal characteristics and availability of the plant as well. For example, where is it usually found? What's its habitat? See the reference article for citation and help;
