- 2. Please mention all study aims in the abstract (including the exploration of the relationship between materialism and SNS addiction).

# Introduction

- In order for the exploration of smartphone use to be meaningful, it should be presented as one of the main outlets for social media use. References to this issue are certainly available.
- 2. Social media addiction has to be better defined and conceptualized. As far as I am concerned, it hasn't been considered a disorder (yet). This should be explored much further and better distinguished from "internet addiction" or "online addiction". These "addictions" are not the main focus of your study. Moreover, all information should be presented together. The paragraph starting with the sentence "The SM addiction is also called SM disorder, excessive SM use, problematic SM use, and compulsive SM use. Uncontrolled use of SM is thought to have negative interactions with depression, anxiety disorders, loneliness, well-being, self-esteem, and self-control (Kuss et al., 2014)." should appear later in the text, when the authors discuss internet and online addiction (and after these constructs are presented).
- 3. It is not necessary to discuss the results of the current study in the introduction.



- 4. End your introduction by stating your research aims.
- 5. The manuscript would benefit from a clearer and summarized version of the current introduction with a greater focus on the relationship between variables of interest and the hypothesis development process.

- Change the following sentence from "With the advancement of networking and intelligence, anxiety about missing out will become increasingly common" — to: With the advancement of networking and intelligence, anxiety about missing out seems to have become increasingly more common. (Researchers should refrain from making assertions without supporting evidence)
- 2. Change the following sentence from Another study aims to Another study aimed
- 3. Change the following sentence from This is the first study to examine social media addiction among Vietnamese adolescents, its relationship to This was the first study

1. In my opinion, this conclusion feels "rushed" and diminishes the significance of your results. I would like to see a more structured discussion before this conclusion is reached. I would also like to advise against generalization of results as this study was conducted on a convenience sample.
