- 1. Starting from the title: the title is ambiguous, so different reviewers could forward different ideas based on their understandings, which is not able to have sealed review ideas. In my view, it is not well written. Does it need to be rewritten? So, per my understanding, it is better to rewrite it: "perceived challenges faced by parents and stakeholders on the need for hospital-based early childhood parenting education services: A Thematic analysis"
- 2. On the abstract section: as we know, any devoted person who may not be familiar with professional abbreviations or acronyms may need to read scientific articles in the abstract. So, since my knowledge concerns that abbreviations and acronyms are not recommended in the abstract section, like: LMIC, NICU. Is it recommended to use them in the long term in the abstract section?
- 3. Methods: since the title deals with perception, the reader expects a phenomenological approach; so the study has to state the approach that they used in brief. Early childhood is not defined and needed to be operationalized?
- 4. Study design and settings: it would be better to narrate the status of Childhood Parenting Education Services in the setting. The status of education service delivery and the level of involvement of parents and stakeholders in education are good to be briefed here?
- 5. Result:

Per my perception, the researchers need to explore the following two big objectives of:

- 1. Identify Challenges faced by parents and Stakeholders on the need for Hospital-Based Early Childhood Parenting Education Services.
- 2. Perception on the need for Hospital-Based Early Childhood Parenting Education Services.

Thus, the results have to answer those two objectives precisely. In my view, it is better to realize it accordingly?

- III). The title, objectives, findings, and conclusion have to be consistent?
