General comments to the authors

Instead of using general statements like "over half of the average company's workers utilize Internet-connected devices," provide specific statistics or examples to support the claims. This will add credibility to the statements and make them more impactful. Instead of referencing the OECD report from 2020, try to find more recent and relevant sources that highlight the current state of digital economy adoption by SMEs. This will ensure the information presented is up-to-date and reliable. Nonetheless, the objectives and research questions are clearly stated.
- 3. The research conducted in this study lacks a clear methodology that adheres to the standards of academic research. The absence of a robust methodology compromises the validity and reliability of the findings. Furthermore, the research fails to highlight the originality or novelty of the study, leaving the reader unaware of any unique contributions made by the research. Moreover, the study lacks an adequate explanation of the present and future situation of SMEs in Malaysia. The absence of a framework specific to Malaysia's context and the failure to utilize relevant literature pertaining to Malaysia's data limits the applicability and relevance of the research.
- 4. Connect the discussion to the objectives: Begin the section by summarizing the main findings and linking them back to the objectives stated in the introduction. This will provide a clear connection between the research conducted and the intended goals of the study.
- 5. Provide a comprehensive summary: Rather than simply mentioning several areas that SMEs need to master, provide a more comprehensive summary of the key areas that SMEs should focus on to modernize their businesses and leverage the digital economy. This could include knowledge transfer, technology adoption, innovation, networking, and intellectual capital development.
