Your topic is definitely relevant and interesting!

However, it would benefit from a few additions, changes, and error corrections:

1. Include definitions at the beginning

What do you mean by AI? A definition is missing! AI is an umbrella term; thus, it is not clear if you are focusing on Learning Analytics, generative AI (such as ChatGPT), intelligent tutors, robots, etc.

It becomes clearer when continuing to read, though!

1. References and Bibliography

It's still a mess! I have seen that you corrected a few errors, but there are still a lot of mistakes. Please unify all your sources; at the moment, there are still different citation styles mixed up (APA, Harvard, MLA,...): sometimes you use the full name, sometimes only the initials, sometimes the year is in brackets, sometimes not (or at the end of the source), sometimes you use commas, sometimes you use points.

1. ResearchGate Question

Your question is "How do you see the evolution of artificial intelligence in the fields of education and finance?" Those are two completely different fields; do you mean the whole finance sector, or do you mean finance education? Finance is mentioned only once again in the paper?

1. Spelling errors throughout the document:

Spaces are missing from time to time.

Artificial Intelligence is sometimes written with lowercase initial letters and sometimes with uppercase initial letters.

It is "Elsevier," not "Elsevir"! Missing e!

"Therefore, according to this" => a comma is missing => Therefore, according to this

"Technological Advances in AI", "Teacher Assistance:"=> This is title case, but the other items of the list are not! Change



that to "Technological advances in AI", "Teacher assistance"

Quotations are missing, e.g., "Research has shown that progressive education can increase student motivation and engagement." You need citations here!

1. Strange phrases:

"makes the academic environment as connected as possible to the direct needs of industries" => as connected as possible?

"The model that we appreciate" => do you mean propose? Why "appreciate"?

1. Citations in Literature Section:

Citation mistakes: Author at all => Author et al. (!!!!)

I would recommend to rephrase phrases like "in this work (Author, 2000)" and "in the paper (Author, 2000), e.g., "Author (2000) proposes/suggests/states ..."

Also: "In this work, Davidson C.N. (2022) proposes solutions regarding ..."

A bracket is missing (and I would also recommend skipping "in this work" => "Davidson (2022) proposes ...")

In-text citations: "Author (2000) suggests ..." or you state a sentence and mark it at the end of the sentence with (Author, 2000). Do not write "(Nyquist JG et al., 2013) sends an exhortation" => "Nyquist et al. (2013) send an exhortation ..."

Please be aware that et al. means that there are several authors and you have to continue with the plural form of the verb.

1. Section Results and Discussion:

I would be interested in the process and which tools (e.g., MAXQDA, NVivo, etc.) you were using. Did you use ChatGPT as well, e.g., for finding keywords, etc.? I would appreciate a more transparent workflow.
